FOOD TRUCK VENDORS will be provided a parking space with no water or electrical hook-ups.

Location: Seminole Okalee Indian Village and Museum, (across the street from Seminole Classic Casino) Vendors will be allowed to set up between NOON and 6:00 PM on Monday, April 17th or beginning at 8:00 AM on Tuesday, April 18th. They must be fully set-up and ready for business by 8:45 AM on Tuesday, April 18th. All vendor vehicles must be moved to the designated parking area following set-up. Tear down can take place at 6:30 PM on Tuesday, April 18th, and must be completed by 8:30 PM.

Ah-Tah-Thi-Ki Museum

Location: Big Cypress Reservation, Ah-Tah-Thi-Ki Museum Park (across the street from the Museum) Vendors will be allowed to set up beginning at 8:00 AM on Thursday, April 18th and must be fully set-up and ready for business by 9:30 AM. All vendor vehicles must be moved to the designated parking area following set-up. Tear down can take place at 4:00 PM on Thursday, April 20th, and must be completed by 5:00 PM.

There will be no early tear down.

The Museum, and Okalee Village reserves the right to reject an application based on content or capacity and to assign booth location. Vendors are responsible for their own set up, tear down, sales, and manning of booths.
